



BID EXPRESS ("BidX") BIDDING GUIDE ("Guide")

Plans Specifications Estimates ("PS&E") Bureau

The New Mexico Department of Transportation ("NMDOT") is mandating electronic bidding, through the use of the BidX website located at <https://www.bidx.com/>, commencing with the September 18, 2015 Bid Opening. This Guide provides direction on requirements for electronic Bid submittal.

Subscribing to BidX

BidX is an internet website that uses Expedite software for electronic Bid submittal. The Bidder submits its electronic Bid with its unique digital id. The digital id is supported by Info Tech. A monthly fee is charged for each digital id.

The NMDOT recommends the use of a desktop computer and a laptop computer for the submission of electronic Bids. Expedite software should be downloaded to both computers acting as a back-up plan in the event of a computer failure and users should also import their digital id into the Expedite software on each computer. It is also recommended to download the electronic bidding files (.EBS or .EBlb files) to the desktop of both computers. Bids cannot be submitted on a network drive. A stand-alone computer is required to submit Bids.

Expedite is currently supported on only the following versions of MS Windows:

Windows 7 or 8.1

The following web browsers are preferred:

IE 9, 10 or 11

Required BidX Services

Bidders shall submit their Bids through the BidX website. To set up an account with BidX, click on the training center link below and follow steps for "Setting up your Account with MyBidx":

There are fees for BidX services. Bidders shall subscribe to the following services:

1) Basic Service

Bidders shall select the basic service to have unlimited viewing and downloading of bidding information with the exception of the Plans and advantage functionality;

2) Required Managing Messages and Notifications Service

Bidders shall select the "Message" box for "Notification Type" "agency message" on the Manage Messages and Notifications tab as shown below;

Also, Bidders shall select both the "Message" and "Email" boxes for "Notification Type" "letting activity" and "proposal activity" on the Manage Messages and Notifications tab as shown below. These selections are required for Bidders to receive updates and addenda per the Advertisement.

Email messages will be sent to the email address provided by the Bidder when subscribing to BidX. Message notifications can be seen on the Bidder's Inbox in My Message Center by clicking on the Messages Icon on the NMDOT Home Page within BidX. On or about the first day of Advertisement the Bidder will receive a notification to advise the Bidder that the NMDOT has posted the Contract for Projects in the Advertisement.

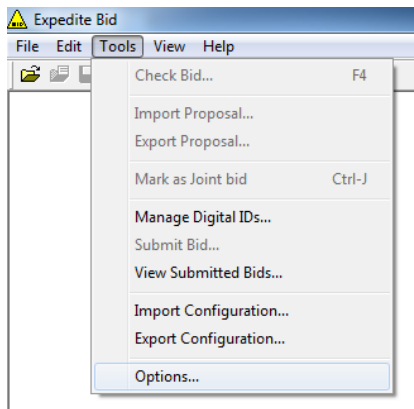

Installing Expedite Software

The current version of the Expedite software ("Software") and the AASHTOWare Project Expedite Export Control form can be located at <https://www.bidx.com/nm/main>. Click on the Expedite link in Downloads.

When the Software has been installed, enter your information and agency information.

In Expedite Bid > Tools > Options enter the following information.



In the Bid Options > Bidder Information enter the information as indicated.

Preparing Electronic Bid for Submittal

In Expedite Bid, open the Proposal required (File > Open Proposal). The .EBS file includes all the Required Documents for Bid Submittal. There are different requirements for Federal-aid funded Projects and State funded Projects. The .EBS file contains folders for the Project dependent on funding type and Work required.

Electronic Bid Guaranties are required on all Projects. Bidder's can register at:

KNOWN ALL MEN by these presents that the Surety having its registered office at the above address are bound unto the NMDOT in the sum of five percent (5%) of the Total Bid Amount as shown on the Project Bid Schedule for which payment well and truly to be made to the NMDOT the Surety binds itself, its successors and assigns by these presents.

The Surety undertakes to pay the NMDOT up to the above amount upon receipt of the NMDOT's first written demand, without the NMDOT having to substantiate its demand, provided that in its demand the NMDOT will note that the amount claimed by the NMDOT is due to the Bidder failing to return the signed Contract and Contract Bonds within fifteen (15) Days of receiving the Contract. The Guaranty will remain in force up to 30 Days after Bid Opening or as it may be extended by the NMDOT, notice of which extension(s) to the Surety is hereby waived.

When entering the Surety Name or Surety Business Address, if the first character is a T, Y or 1 an error will occur. The Bidder must use a comma , as the first character in order to avoid this. This issue will be addressed in the future.

The Bidder shall use the "File Attachment Upload" folder below to attach the required documents below in the form of a zip file. The maximum zip file size for attachments is 3MB.

Review the Electronic Bid Submittal

BidX will allow submittal of an incomplete Bid. It is the Bidder's responsibility to verify and resolve the required documents, information and data so that the Bid is not rejected.

Submitting Electronic Bids

After completing the information as required, the Bid is ready for submission. Refer to "Bid Submission" in the Training Center.

Bidders shall print the Bid Submission Receipt and maintain the same in its records as proof of its Bid submittal.

Bid Withdrawal Before Bid Opening

To withdraw Bids submitted, prior to Bid Opening, in Tools > View Submitted Bids, follow the Bid View Wizard process to withdraw Bids.

Automatic Bid Withdrawal

When submitting multiple Bids, the Bidder has the option to withdraw Bids. Refer to "Automatic Bid Withdrawal" in the Training Center. The automatic Bid withdraw functionality only supports an "OR" condition. i.e. Withdraw call order 003 if you are the low Bidder on call order 001 _OR_ 002. The automatic Bid withdraw does not allow you to set a condition of withdrawing if you are the low Bidder on call orders 001 _AND_ 002.
